PHILADELPHIA, June 3, 2014 — Today, Delaware Investments National Municipal Income Fund re-declares a monthly income dividend of \$0.065000 a share, an increase of \$0.005 from the previous month's dividend and the incorrect amount declared yesterday.

The monthly dividends for Delaware Investments Colorado Municipal Income Fund, Inc. and Delaware Investments Minnesota Municipal Income Fund II, Inc. (together, with Delaware Investments National Municipal Income Fund, the "Funds") remained the same as the amounts reported on June 2, 2014.

The investment objective of Delaware Investments Colorado Municipal Income Fund, Inc. and Delaware Investments Minnesota Municipal Income Fund II, Inc. is to provide current income exempt from federal income tax and from the personal income tax of its state, if any, consistent with the preservation of capital. The investment objective of Delaware Investments National Municipal Income Fund is to provide current income exempt from regular federal income tax consistent with the preservation of capital. In addition, each Fund has the ability to utilize leveraging techniques in an attempt to obtain a higher return for the Fund. Currently, each Fund has outstanding a series of variable rate preferred shares as leverage.
